**NOTICE:** If you plan to camp before the trip officially begins or after it ends, you must make reservations with the campground BEFORE arrival to reserve a site at (610) 588-0553. ### DIRECTIONS From Route 80

Route 80 West to Exit 4B in New Jersey (Portland-Columbia), follow signs to Portland. Cross Portland-Columbia toll bridge. Follow Route 611 South (to the left). Make 3rd RIGHT on to Railroad Ave. Go to end and make LEFT on Million Dollar Highway. Continue straight to end. Make LEFT on Blue Mountain Drive. Camp Charles is ahead on the LEFT. When you enter, stop and sign in at the Camp Store. Go straight back past the lake to the woods. Follow road in to woods and check-in will be ahead, look for the signs. **When you enter the campground, go in to the store and sign in.**

**Pay the committee at our check in table if you have not pre-paid.**

A tentative schedule of meetings will be available at the committee table. The Campground offers a pool, volleyball, basketball, horseshoes and fishing. Nearby, there is also horseback riding, White Water Rafting and MANY other fun activities.

Remember to bring your tent, food, and a tarp (in the event of rain.)
